APPLICATION FOR MEMBERSHIP and ELECTRIC SERVICE

The undersigned (herein called the applicant) hereby applies for membership and agrees to purchase energy from the NUEVA VIZCAYA ELECTRIC COOPERATIVE (herein after called cooperative), upon the following terms and conditions:

- 1. The applicant shall pay to the cooperative a membership fee of one hundred pesos (P 100.00) which, if this application is accepted by the cooperative, shall constitute the applicant's membership fee; the applicant shall also pay other charges relative to his application and that the payment of these fees is not a guarantee of providing service unless applicant has fully complied with the requirements of his application for membership and electric service.
- 2. The applicant shall subscribe a minimum of twelve (12) shares at one hundred pesos (P100.00) per share which will serve as his subscribed share capital to the cooperative. The applicant may pay in full his subscribe share capital or may initially pay at least two (2) shares upon submission of his application form and the remaining ten (10) shares shall be paid in equal monthly installment for a period not exceeding sixty(60) months.
- The applicant shall, when electric energy becomes available, purchase from the cooperative his entire electric energy
 requirement and will pay monthly rates to be determined from time to time in accordance with the policies of the
 cooperative.
- 4. The applicant will cause his premises to be wired and metered in accordance with the specification approved by the cooperative and that after said installation; the applicant will always keep his premises open to duly authorized personnel of the cooperative for the purpose of inspection and implementation of cooperative policies and programs at any reasonable time.
- 5. The applicant shall comply with and be bound by the provision of the charter and BY-LAWS of the cooperative and its policies, rules and regulations as may from time to time be adopted by the cooperative.
- 6. The applicant shall be jointly and severally liable with the occupant of his premises for any unpaid electric bills that re left unpaid y the occupant.
- 7. The applicant shall provide and grant the necessary easements and/or RIGHT-OF-WAY, free of charge, in favor of NUVELCO for the installation of poles and electric lines and all the accessories connected therewith including the erection of guy wires, trimming of trees, free access for repairs, inspection, maintenance of lines and other works necessary for it to be able to fully and effectively implement, extend and perpetually maintain its services.
- 8. The cooperative shall not be held liable for damages to the applicant for its failure or delay to supply electricity to said premises due to fortuitous events or conditions beyond the control of the cooperative, acts or omission of the applicant or non-compliance of the terms and conditions of this application.
- 9. The applicant by becoming a member assumes no personal liability or responsibility for any debts or liabilities of the cooperative beyond his subscribed share capital and it is expressly understood that under the law his private property is exempted from execution for any debts or liabilities.
- 10. The acceptance, approval and due execution of this application by the cooperative shall constitute an agreement/contract between the applicant and cooperative. This contract shall be for one (1) year from the date application is approved and accepted by the cooperative and thereafter as long as the applicant has need for electric service and abides by the terms and conditions of this agreement and the policies, rules and regulations of the cooperative.
