



APPLICATION FOR MEMBERSHIP and ELECTRIC SERVICE

The undersigned (applicant) hereby applies for membership, avail the services and agrees to purchase energy from the NUEVA VIZCAYA ELECTRIC COOPERATIVE (cooperative), upon the following terms and conditions:

1. The applicant shall pay to the cooperative a membership fee of one hundred pesos (P100.00) which, if this application is accepted by the cooperative, shall constitute the applicant's membership; the applicant shall also pay other charges relative to his/her application and that the payment of these fees is not a guarantee of providing service unless applicant has fully complied with all the requirements of his/her application for membership and electric service.
2. The applicant shall subscribe a minimum of twelve (12) shares at one hundred pesos (P100.00) per share which will serve as his/her subscribed share capital to the cooperative.
3. The applicant shall, when electric energy becomes available, purchase from the cooperative his entire electric energy requirement and will promptly pay monthly bill and other fees that may be required by the cooperative and other national agencies from time to time;
4. The applicant will cause his/her premises to be wired and metered in accordance with the specifications approved by the cooperative and that after said installation, the applicant will always keep his/her premises open to duly authorized NUVELCO personnel for the purpose of inspection and implementation of cooperative policies and programs at any reasonable time.
5. The applicant shall comply with and be bound by the Articles of Cooperation and By-laws of the cooperative and its policies, rules and regulations as may from time to time be adopted by the cooperative. This includes compliance with pertinent laws, rules and regulation by the government and its instrumentalities.
6. The applicant shall be jointly and severally liable with the occupant of his/her premises for any unpaid electric bills that left unpaid and shall not perform or do any act prejudicial to the interest of NUVELCO.
7. The applicant shall provide and grant the necessary easements and/or RIGHT-OF-WAY, free of charge, in favor of NUVELCO for the installation of poles and electric lines and all the accessories connected therewith including the erection of guy wires, trimming of trees, free access for repairs, inspection, maintenance of lines and other works necessary for it to be able to fully and effectively implement, extend and perpetually maintain its services.
8. The cooperative shall not be held liable for damages to the applicant for its failure or delay to supply electricity to said premises due to fortuitous events or conditions beyond the control of the cooperative, acts or omission of the applicant or non-compliance of the terms and conditions of this application.
9. The applicant by becoming a member assumes no personal liability or responsibility for any debts or liabilities of the cooperative beyond his subscribed share capital and it is expressly understood that under the law his private property is exempted from execution for any debts or liabilities.
10. The acceptance, approval by the board and due execution of this application by the cooperative shall constitute an agreement/contract between the applicant and cooperative. This contract shall be effective from the date application is approved and accepted by the cooperative and thereafter as long as the applicant has need for electric service and abides by the terms and conditions of this agreement pertinent laws and the policies, rules and regulations of the cooperative.
11. That any misrepresentation, dishonesty and falsification in the execution of this application shall be a ground to the disconnection of service even without prior notice and shall be criminally, administratively, and civilly liable in the court of law.
